### Safety Advisor Report

### Summary of Injury/Incident Reports for Faculty of Science

L. Lucas described the Injury/Incident Reports that had been submitted for Science during May.

Incident #7329	Incorrect emergency alarm gave a do not evacuate message. Once the fire alarm is pulled, Security is unable to send out notifications since a fire alarm overrides any other alarm. Security recommended downloading the SMUsafe app and adding the push notifications but there's still bugs to work out.
Incident #7350	Fainting spell while in observatory. During a public tour a person felt dizzy and slid down the wall to the floor. Unknown cause, they left with their partner once they felt better. The rotating ceiling was paused in case that was the cause. Prevention: brief episode couldn't be identified but staff have first aid and knew what to do during the event.

## OHS & Wellness Consultant: JOHSC Activity and Information

JOHSC minutes: none at this time.

V. Wadman said the Intro to OSH course hasn't been sent out yet but is coming soon. There are 2000 spaces on the PD platform and faculty, staff and others will be on Brightspace.

They advised that the number of free online courses, (paid for by the Department of Labour, Skills & Immigration), has increased to eight courses annually. The information will be available in the next safety email.

The OHS annual policy has been revised and is available on the website, along with the heat stress guidelines.

The violence in the workplace guidelines should be out in July but may be August. V. Wadman will send the link to the committee.
